


# A LETTER TO OUR TOWN.

# GFWC WV Director of Jr. Clubs' Message

Dear GFWC WV Clubwoman,

I can hardly believe that the end of this amazing journey is coming to an end. I feel at a loss for words but still feel that there is so much to be done. I am truly thankful to each of you for allowing me to serve as the GFWC WV Director of Junior Clubs these past few years. I have been blessed to have the very best examples for being a leader, having courage and dedication, and working hard while having fun!

In just a few short weeks, we will be together again at The Greenbrier to celebrate your many accomplishments from the past year. I am in awe of the enthusiasm and passion that each of you have put into the GFWC WV combined state project "Feed our Future." We have made such wonderful strides in providing food for so many children in our state and I hope your clubs will continue to support this project. West Virginia children need our love and support now more than ever with proposed changes in benefits. When we started this endeavor, 1 in 4 children in West Virginia did not have enough food to eat but last year GFWC WV provided over 23,000 meals! This is a huge accomplishment and I look forward to reading the reports this year and watching that number increase.

I would like to announce that GFWC WV has the privilege of having the GFWC Director of Junior Clubs, Jolie Frankfurth, attend our Convention in March and she will be the keynote speaker at the Junior/General Luncheon. This year the Junior/General luncheon will focus on Operation Smile and we will be collecting items for Smile Bags. GFWC has been a partner with Operation Smile for many years as we share the belief that every child suffering from cleft lip or cleft palate deserves exception surgical care as if they were our own. After receiving surgery, each child receives a Smile Bag, the perfect gift to cheer up a healing child. Smile Bags are filled with small personal care items as well as toys, stickers and a mirror to see their new smile. Our own GFWC WV President, Sharon Sheridan, has graciously sewn and donated several smile bags.

## **We will be collecting the following items:**

- Small shampoo (0.85 to 1.4 oz. size, screw-on top only)
- Small comb (no rat tails)
- New wash cloth
- Bar of soap (small hotel size)
- Travel-sized toothpaste (at least 6 months from expiration date)
- Child-sized toothbrush (single package)

- Small stuffed animal (Beanie Baby® size)
- 8-pack box of non-toxic crayons
- Small square mirror (approximate size 3"x 3")

It has been a privilege to work with such a devoted group of women. Thank you all for embracing me and assisting me on this journey. I would like to thank Sharon Sheridan – GFWC WV President, the GFWC WV Board and Council, Dana Richardson - Director-elect, Rebecca Roll - Advocates for Children Chairman, Amy Romano - Juniorette Chairman, the Junior and Juniorette Club Presidents and all of the members (especially my Huntington ladies) for being ready and willing to do whatever needed done. # GFWC Membership: *It's the Real Deal*

## GRANTS

GFWC grants are available to assist clubs with recruitment efforts and to districts to assist with club building efforts. Funds are designated each GFWC fiscal year beginning July 1 and ending June 30 to help underwrite membership recruiting and rebuilding in your community. GFWC offers \$50 for club member recruitment programs and \$100 for district new club building programs.

To apply for a club membership grant, please visit [www.GFWC.org/Membership](http://www.GFWC.org/Membership), to receive an application. You must return the application form to GFWC Headquarters at least 45 days prior to your event. While a GFWC club or district may submit grant applications for separate events, GFWC will award a maximum of one grant per club/district per GFWC fiscal year.

This is a great opportunity for clubs and districts to help with their recruiting and building efforts. Take advantage of this benefit of belonging to GFWC!




